1. Announcements
  - a. Rose shared fulfillment statistics covering the calendar year to date
  - b. The problem with records not showing in Marmot's VuFind discovery layer has been fixed, everything is now displaying properly
  - c. The authentication problem related to certain initials and middle names is not completely resolved, but the fix should be in the next version of Millennium (2011 1.6).
  - d. The problems with information out of sync between Encore and the classic catalog has been fixed.
  - e. There was a problem with some records not being contributed from specific sites, it has also been fixed.
  - f. There is still a problem with duplicate barcodes between Denver Public and the Flatirons consortium. With Innovative's purchase of Polaris, there is hope for a real solution involving full integration of DPL that wouldn't rely on the DCB box. That integration would solve this problem.
  - g. In Millennium Release 2014, new features will include a pass-through search to the Encore version of Prospector. 2014 may also solve the problem of missing pick-up locations for some Prospector requests for DPL patrons.
  - h. The Alliance renewed the contract for Encore and will receive a 50% discount on harvesting up to five more open access collections..
  - i. On July 11<sup>th</sup>, the Alliance will host a Research Data Management Conference.
2. Prospector/Mobius peer-to-peer: local system configuration & preparation for August 1<sup>st</sup> launch.
  - a. Rose asked each Prospector site for a technical contact and she will be sending technical info to them.
  - b. Sharon Walker from the CLiC office shared information about how the courier will connect to Mobius. The new courier service will be called PROMO and will be billed as part of your regular courier contract. We will package materials the same as for the

Colorado courier, but there will be a different system for printing courier slips. These slips must be machine-printed, not handwritten, for materials going to Mobius. The Mobius libraries will continue to use bags for their materials – when we receive a bag, we can simply put the empty bag in a courier bin to return it, we do not have to use the bags. Sharon will send out a draft FAQ about this new system and will want feedback.

- c. Rose shared a draft document covering some of the system changes that will be required to implement the peer-to-peer system with Mobius, she will share the final version with the technical contacts. The group discussed some questions related to loan rules and other system parameters.
- d. Desired timeline is fast, in order to try to have the system up and running by August.
- e. George will contact Innovative at the ALA Conference. They may provide some marketing material for us to use as we implement the Prospector-Mobius connection.
- f. A listserv for Prospector and Mobius libraries has been set up, details to come.
